Selection of "high impact" academic experiences, courses, and programs that are designed to increase competencies in pre-determined knowledge areas for all graduates at a given institution.

The faculty are the developers and stewards of the curriculum.

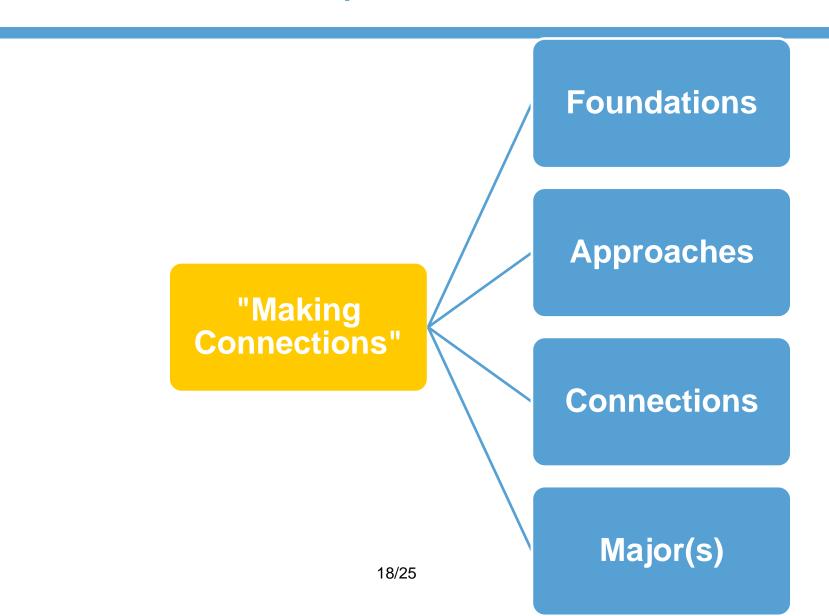

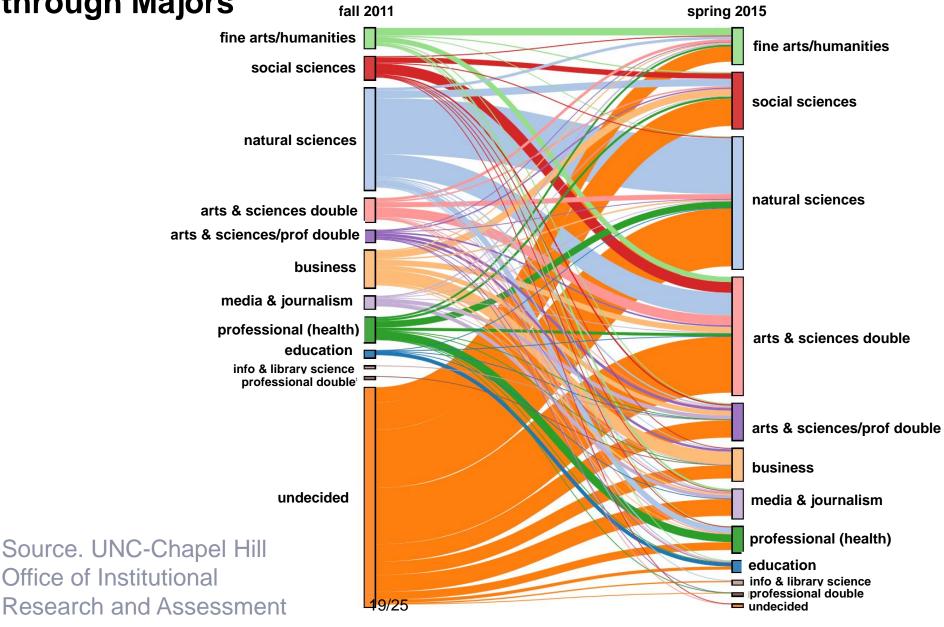
