BOG Aug 2018 Resolution

"...provide a plan for a *lawful* and *lasting* path that protects public safety, preserves the monument and its history, and allows the University to focus on its core mission of education, research, economic stimulation, and creating the next generation of leaders."

"Present to the Board of Governors a plan for the monument's disposition and preservation..."



BOT May 2015 Resolutions

Resolution 1: Curating UNC campus, teaching UNC's history:


- 1. Create historical markers for McCorkle Place, Saunders Hall
- 2. Evaluate current information on our buildings, monuments, memorials, landscapes
- 3. Study feasibility of a public space to house a permanent collection of UNC's history.
- 4. Explore options for creating an on-line orientation program or course

(Resolution 2: Renaming Saunders Hall to Carolina Hall, Explain Saunders; Resolution 3: Freeze on renaming buildings)



Approach

- Lawful, lasting plan fits within the current law
- BOG Charge
- BOT May 2015 resolutions
- Collection, analysis of feedback
- Public safety; core University mission
- Next steps: submit to BOG







Site evaluation

- Fit within the current law
- Aligned with BOG, BOT resolutions
- Public safety
- Structural feasibility
- Community input
- Costs



Public safety

- National security consultants
- Campus climate, current police capabilities, prevailing laws
- Key findings:
 - 1. UNC Police effective day-to-day
 - 2. New challenges require more resources
 - 3. Place artifact in a single-purpose building
 - 4. Recommend new, free-standing building
 - high-tech security, buffer zone around perimeter





Costs

- Thorough cost analysis
- Specific to each site
- One-time and recurring expenditures estimated
- Unique security issues for each site
- Programming costs similar

Point One	Disposition and preservation of the artifacts
Point Two	Continuation, expansion of the historical contextualization of campus
Point Three	Establishment of a University History and Education Center
Point Four	Creation of McCorkle Place Gateway



Preservation, Disposition of the Statue and Commemorative Tablets




Off-campus location - preference, but not legal

New construction, on-campus location – best legal option



Recommendation: New construction, Odum Village site

- On campus; available land
- Aligns with BOG, BOT resolutions
- Fits N.C. Gen. Stat. § 100-2.1
- Meets Security Panels' criteria





Free-standing building:

- Campus growth area
- New construction
- Single-use
- Buffers
- State-of-the-art security and programming
- Accessible to the public

- 2016–2019: Carolina Hall renaming, Saunders contextualization; McCorkle Place contextualization

Creation of McCorkle Place Gateway




McCorkle Place Gateway
