WHEREAS, Ms. Washington provided invaluable advice and counsel to the administration, the Board of Trustees, faculty, staff, students and local and national organizations.

WHEREAS, Dr. Caudill is an active entrepreneur and supporter of entrepreneurial ventures as a co-teacher and leader in the Entrepreneurship Minor, creator of the Chancellor's Faculty Entrepreneurship Bootcamp, and member of the Carolina Research Ventures Fund; and

WHEREAS, Dr. Caudill, through his interest in innovation and research including the leadership gift to name Caudill Labs, helped lay the foundation for Carolina's reaching the highest echelons of research institutions nationwide as one of the top institutions for innovation and entrepreneurship; and

WHEREAS, Dr. Caudill determined that this Board of Trustees would take on the complex, controversial topic of race and place at Carolina, guiding the Board to seek a comprehensive approach; and

Designer Selection

1. National Pan-Hellenic Council Garden

The University of North Carolina at Chapel Hill advertised for Designers in on March 20, 2019. The project will develop a gathering place to recognize the National Pan-Hellenic Council (NPHC). The NPHC is a collaborative organization of nine historically African-American, International Greek lettered fraternities and sororities. Each chapter will be recognized individually. The garden will be programmed as a gathering space for its members as well as the entire campus community. The project site is in the Student and Academic Services Building courtyard. The scope will include demolition, grading, utility work, irrigation, pavement, steps, railing, lighting, plantings, signage, and recognition elements for the gathering area.

The project budget is \$750,000 and will be funded through gifts. The project was advertised on March 20, 2019. Six (6) proposals were received. Three (3) firms were interviewed on April 29, 2019. Members of the Board of Trustees did not participate in

the interviews. The committee recommended the selection of three (3) firms in the following priority order:

2. Marsico Biomedical Research Imaging Center & PET/CT Renovations

Located in Marsico Hall, the Biomedical Research Imaging Center (BRIC) 3T MRI has been utilized heavily and it is anticipated that the demand for this MRI will soon exceed its operating capacity. This project will relocate an existing PET/CT to add another 3T MRI to accommodate present and future research needs. The new MRI and PET/CT rooms will require specialized floor and wall shielding, respectively, as well as the construction of an isolated floor slab to limit building vibration.

The project budget is estimated at \$3,100,000 and will be funded through School of Medicine Trust. The project was advertised on April 5, 2019. Six (6) proposals were received. Three (3) firms were interviewed on May 16, 2019. Members of the Board of Trustees did not participate in the interviews. The committee recommended the selection of three firms in the following priority order:

Construction Manager at Risk Selection

1. S1 Parking Deck

This project is to construct a new 450 space parking deck at the site of the current S1 surface parking lot off Paul Hardin Drive. This project is being designed in parallel with an adjacent Central Generation Plant for UNCH as the two buildings will share a common wall. Extensive underground utility relocation and roadway improvements are part of this scope.

The project budget is \$14,443,516 and will be funded through the Transportation & Parking Trust Fund as well as self-liquidating debt. The project was advertised on April 5, 2019. Six (6) proposals were received. Four (4) firms were interviewed on May 10, 2019. A member of the Board of Trustees participated in the interviews. The committee recommended the selection of three (3) firms in the following priority order:

Design-Builder Selection

1. Solar Array and Energy Storage at Horace Williams Airport

This is an engineering project for a renewable energy system consisting of a ground-mounted, moveable photovoltaic array coupled with a battery storage system. Project will be located on vacant land at Carolina North (former Horace William Airport). Design-Build team will be providing full design and construction services, including sizing recommendations for PV array and storage battery bank; design drawings and specifications; and complete construction of the renewable energy system.

The project budget is \$1,700,300 and will be funded by the Utility Infrastructure Fee Trust Fund. This project was previously designed under design-bid-build process and that design contract was terminated in January 2019. Energy Services decided to pursue project under design-build delivery. The basic scope and site of the project have not changed.

The design-build RFQ was first advertised on March 13, 2019. Seven (7) submittals were received but only two of the submittals were complete proposals so the project was re-advertised on April 18, 2019. Seven (7) proposals were received and four (4) teams were interviewed on May 8, 2019. Members of the Board of Trustees did not participate in the interviews. The committee recommended the selection of three firms in the following priority order:

The firms were selected for their past performance on similar projects, strength of their team and their creative vision for the project.

Design Approval

1. Carroll Hall Addition – Curtis Media Center

The School of Media and Journalism is seeking to build a roughly 13,000 gross square foot building adjacent to Carroll Hall to house flexible learning spaces, production studios, and technical support spaces. The project site, at the location of the current Phillips Annex, was approved at the November 2018 Board of Trustees meeting.

The anticipated project budget is \$7,200,000. The School of Media and Journalism has received gift commitments to fund this project.

A motion came from committee to approve the design. Secretary Grumbles seconded and it passed.

Property Acquisition by Lease

Gordon Merklein, Associate Vice Chancellor for Real Estate Operations presented a request to acquire approximately 22,000 square feet of rental space from Cousins Properties/Northwood Ravin, Inc. on the sixth floor of Carolina Square located at 123 West Franklin Street in Chapel Hill. This space will be built-out for the purpose of relocating selected administrative offices currently located on campus. This relocation of administrative office space will create needed on-campus space to be used by academic and/or other core functions. The lease term will be for 10 years at a full-service rental rate of \$33.75 per square foot (\$742,500 total first year) escalating 2.5 percent annually. Lease commencement is expected to begin October 1, 2019.



I am pleased to write this letter to offer you the position of Dean of the Graduate School at The University of North Carolina at Chapel Hill effective August 1, 2019 on the terms and conditions outlined herein. This will be subject to approval by the University Board of Trustees.

Your initial twelve-month annual salary will be \$285,000. Your salary will be reviewed at least annually, subject to the compensation policies of the Board of Trustees and Board of Governors. Your appointed position will report to the Chancellor with administrative assignment to the Executive Vice Chancellor and Provost. This will be an "at will" appointment of indeterminate length with a review every five years and subject to continuation or discontinuation at the discretion of the Chancellor.

I am supportive of the hiring of an additional non-tenure track fixed-term faculty member to support emerging programs within your office, particularly in the area of interdisciplinary graduate education. We can discuss the best mechanism to accomplish this goal following your arrival.

This appointment is subject to the "Employment Policies for EHRA Non-Faculty Tier 1 Senior Academic and Administrative Officer Employees of The University of North Carolina at Chapel Hill" as originally adopted and as they may be periodically revised from time to time. According to the Policies, you will be entitled to 26 days of annual leave per year. Sick leave is earned at the rate of 1 day per month or 12 days per year. On December 31, of each year, any annual leave accrued in excess of 30 days will automatically be converted to sick leave. There is no limit to the amount of sick leave you may accrue.

At the end of appointment, EHRA employees are eligible for vacation and bonus leave payout or the transfer of leave, if appropriate. The full Policies are available for reference online at https://hr.unc.edu/employees/policies/ehra-non-faculty-policies/.

You will be required to attend a new employee orientation within 30 days of your hire. Alicia Rogers, Human Resources Manager for the Graduate School, will be able to assist you with the registration upon your arrival. You will be recommended for a tenured faculty appointment at the Professor rank within the School of Medicine Department of Biochemistry and Biophysics, pending approval by the UNC-Chapel Hill Board of Trustees. At the end of a deanship, tenured faculty are eligible to retreat to their faculty appointment in accordance with the provision of the "Separation and Retreat Policy

for Senior Academic and Administrative Officers (as Amended, 05/02/2010)" available for reference online at http://hr.unc.edu/policies-procedures-systems/epa-non-faculty-employeepolicies/appointment-and-end-of-appointment/separation-and-retreat-policy-for-senioracademic-and-administrative-officers/.

You may be reimbursed for customary and reasonable expenses related to moving your household goods up to a maximum amount of \$20,000. Reimbursement must be requested no later than 180 days following the date of hire and is subject to University procurement rules which are summarized in the following document on the web at http://finance.unc.edu/files/2012/11/moving.pdf.

You will have a reserved parking space subject to the annual costs for parking on campus. You will receive two season tickets to the men's football and men's basketball games. The basketball tickets will be in the Ring Section where the other deans are positioned. Please note that the tickets are considered taxable income.

Suzanne, I would like to emphasize to you how excited I am that you may be joining us here at UNC-Chapel Hill. I believe that the Graduate School is well positioned to make the transformative changes you and I discussed during your last visit. I am anxious to work with you in exploring the development of new graduate programs as well as introducing new pedagogical approaches towards graduate education. SECTION A: INTRODUCTION, DEFINITIONS, AND INSTRUCTIONS

1. Introduction

Under Section 300.5.2 of the UNC Policy Manual, an employee who is exempt from the State Human Resources Act (an "EHRA employee") must submit this petition for review before becoming a candidate for or accepting an appointive or elective public office.

Pursuant to the North Carolina Human Resources Act and the North Carolina Public Records Act, this petition and associated approvals are public records and will be released upon request

2. Relevant Definitions1

- a. "Appointive public office" means a public office that is filled or obtained by means other than an election.
- b. "Conflict of commitment" relates to an individual's distribution of time and effort between obligations to University employment and participation in other activities outside of University employment. A conflict of commitment occurs when the pursuit of such outside activities involves an inordinate investment of time or is conducted at a time that interferes with the employee's fulfillment of University employment responsibilities.
- c. "Conflict of interest" means situations in which financial or other personal considerations, circumstances, or relationships may compromise, may involve the potential for compromising, or may have the appearance of compromising, an employee's objectivity in fulfilling their University duties or responsibilities, including research, service, teaching activities, and administrative duties.
- d. "Elective public office" means a public office that is filled or obtained through the results of an election.
- e. "Full-time employee" means an individual who is employed by the University at least three-quarter (3/4) time, including faculty who are employed on a nine-month per calendar year basis.
- f. "Major public office" means (1) any public office requiring full-time service, regardless of the amount of compensation; (2) any public office requiring service on a part-time basis for which compensation is more than nominal²; or (3) membership in the North Carolina General Assembly.
- g. "Minor public office" means any public office that is not a major public office.
- h. "Part-time employee" means an individual who is employed but who is not a full-time employee.
- "Public office" means any national, state, or local governmental position of public trust and responsibility, whether elective or appointive, which is created, prescribed, or recognized by constitution, statute or ordinance (other than within the University of North Carolina).

3. Instructions for Completing Section B of the Petition

The table on the following page specifies which portions of Section B the petitioner must complete. Petitioners also should read Section 300.5.2 in its entirety to ensure they are aware of all applicable requirements and deadlines.

¹ The definitions in Sections 300.5.1 and 300.5.2 of the UNC Policy Manual are incorporated herein by reference.

In this context, "compensation which is more than nominal" means actual annual compensation or expected annual compensation, whichever is greater, in excess of \$10,000, excluding direct reimbursements for expenses incurred by the officeholder incident to holding office, whether such expenses are calculated on a per diem basis or an actual expense basis.

With respect to each such decision rendered by a board of trustees, the chancellor shall transmit to the Committee on University Governance of the Board of Governors a report, containing such information as the committee may specify, concerning the action of the board of trustees.

BYLAWS OF THE BOARD OF TRUSTEES

AT CHAPEL HILL

ARTICLE 41 – ORGANIZATION

Section 1.01 - Membership

Section 101 - Membership for Year Ending June 30, 1973

a. For the period commencing July 1, 1972, and ending June 30, 1973, the membership of the Board of Trustees of the University of North Carolina at Chapel Hill shall consist of the sixteen persons elected to the Board by and from the membership of the former Board of Trustees of the University of North Carolina on May 22, 1972, and the President of the Student Government ex officio.

If any vacancy should occur in the elected membership of the Board of Trustees during the year beginning July 1, 1972, the Governor may appoint a person to serve for the balance of the year.

Section 102 - Membership after June 30, 1973

- a. Effective July 1, 1973, the The University of North Carolina at Chapel Hill shall have a Board of Trustees composed of thirteen persons chosen as follows:
 - <u>i.</u> Eight <u>selected elected</u> by the Board of Governors of <u>the The</u> University of North Carolina, <u>Four appointed by the Governor, and</u>;
 - ii. Four appointed by the General Assembly, two of whom shall be appointed upon the recommendation of the President Pro Tempore of the Senate, and two of who shall be appointed upon the recommendation of the Speaker of the House of Representatives; and
 - iii. The President of the Student Government ex officio.

The Board of Governors, in electing members of the Board of Trustees to serve terms commencing July 1, 1973, shall designate four persons for four year terms and four for two year terms; and the Governor, in making appointments of members of the Board of Trustees to serve terms commencing July 1, 1973, shall designate two persons for four year terms and two for two year terms. In every odd-numbered year after 1973, the Board of Governors shall elect four persons to the Board of Trustees and the Governor General Assembly shall appoint two persons to the Board of Trustees; and the term of office of all such elected or appointed trustees (excluding the ex officio trustee) shall be four years, commencing on July 1 of each such odd-numbered year.

From and after July 1, 1973, whenever b. Whenever any vacancy shall occur in the membership of the Board of Trustees among those appointed by the Governor General Assembly, it shall be the duty of the Secretary or Assistant Secretary of the Board of Trustees to inform the Governor General Assembly of the existence of such vacancy, and the Governor shall appoint a person to fill the unexpired termvacancy shall be filled as provided in N.C.G.S. 120-122, and whenever any vacancy shall occur among those elected by the Board of Governors, it shall be the duty of the Secretary or Assistant Secretary of the Board of Trustees to inform the Board of Governors of the existence of the vacancy, and the Board of Governors shall elect a person to fill the unexpired term. Whenever a member shall fail, for any reason other than ill health or service in the interest of the State or nation, to be present for three successive regular meetings of the Board of Trustees, histhat person's place as a member shall be deemed vacant.

From and after July 1, 1973, any c. Any person who has served two full four-year terms in succession as a member of the Board of Trustees shall, for a period of one year, be ineligible for election or appointment to the Board but may be elected or appointed to the board of another institution.

From and after July 1, 1973, nod. No member of the General Assembly or officer or employee of the State or any constituent institution of The University of North Carolina or spouse of any such member, officer or employee shall be eligible for election or appointment as a member of the Board of Trustees. Any trustee who is elected or appointed to the General Assembly or who becomes an officer or employee of the State or of any constituent institution of The University of North Carolina or whose spouse is elected or appointed to the General Assembly or becomes such officer or employee shall be deemed thereupon to resign from his membership on have resigned as a member of the Board of Trustees.

e. No person may serve simultaneously as a member of the Board of Trustees and as a member of the Board of Governors. Any trustee who is elected or appointed to the Board of Governors shall be deemed to have resigned as a trustee effective as of the date that his or her term commences as a member of the Board of Governors.

Section 1031.02 - Officers of the Board of Trustees

a. At the first <u>regular</u> meeting after June 30 of each year, the Board of Trustees shall elect from its membership a <u>ChairmanChair</u>, a Vice <u>ChairmanChair</u>, and a Secretary, each of whom shall serve for a term of one year and until his <u>successor is elected</u>. <u>If aor her successor is elected</u>. <u>In no event shall officer elections take place before July 1, or before the swearing in of new Board and the successor is elected. In the successor is elected.</u>

members whose terms commence on July 1. Any member of the Board of Trustees who is or who shall be duly appointed and sworn in at the time of the election shall be eligible to serve as an officer, regardless of length of service on the Board. Elections shall be conducted such that each member of the Board of Trustees, including newly appointed members, can fully participate in the nomination, consideration, and election of officers. A nominating committee convening prior to July 1 to determine a slate of officer candidates may include members who have been appointed but have not yet been sworn in, but may not include current members whose terms end June 30 and who have not been reappointed. Each elected officer shall serve until his or her successor is elected. If the term of the Chair expires before his or her successor as Chair is elected, then the Vice Chair shall become the interim Chair until the Chair's successor is elected. In the event that any officer of the Board of Trustees is unable or unwilling to serve for any period of time, the Board of Trustees may elect from its membership an interim officer for such position. If a permanent vacancy occurs in any of these offices, the Board of Trustees shall elect a person to serve for the remainder of the unexpired term.

<u>b.</u> The Board of Trustees may also elect an Assistant Secretary, from among the members of the Chancellor's staff. Copies of all minutes, papers and documents of the Board of Trustees may be certified by its Assistant Secretary with the same force and effect as though such certification were made by the Secretary of the Board.

Section <u>1041.03</u> - Committees

The Board of Trustees may delegate to such committees as it may create such of its powers as it deems appropriate. create any number of advisory committees, each consisting of two or more trustees, to make recommendations to the Board. The Chair shall appoint and remove the members of such committees. Whenever any vacancy shall occur in the membership of a committee, the Chair may appoint a member to fill the vacancy.

ARTICLE II – MEETINGS

Section 2012.01 - Regular Meetings

There shall be six regular meetings of the Board of Trustees each year. These meetings shall be held on the fourth Thursday and the preceding Wednesday in the months of January, March, May, July, September, and November, unless otherwise determined by the Board. A notice specifying the time and place of each regular meeting of the Board shall be mailed provided electronically by the Secretary or Assistant Secretary to each member of the Board at least ten days in advance of the meeting date. Under appropriate circumstances, the Chair, in his or her sole discretion, may authorize one or more members of the Board of Trustees to attend a regular meeting of the Board by telephone, video conference or other electronic means so long as (i) all members of the Board attending the meeting can communicate simultaneously with one another, including the member or members not physically present, and (ii) the arrangements for such a meeting comply with the applicable State laws concerning the conduct of electronic meetings of public bodies. Any matter of business may be considered at a regular meeting of the Board. [Amended October 25, 1991, November 21, 1997, and September 26, 2002]

Section 2022.02 - Special and Emergency Meetings

A special meeting of the Board of Trustees may be called by the Chairman Chair, and shall be called by the Secretary or Assistant Secretary upon the written request of not fewer than six members of the Board. A special meeting called by the Secretary or Assistant Secretary shall be held within ten days of receipt by the Secretary or Assistant Secretary of the sixth written request for such special meeting. A notice specifying the time and place of a special meeting of the Board shall be mailed or provided electronically by the Secretary or Assistant Secretary to each member of the Board at least forty-eight hours in advance of the meeting date, but less than forty-eight hours' notice may be given by telephone when, in the opinion of the Chairman Chair, an emergency exists. One or more members of the Board of Trustees may attend any special or emergency meeting of the Board by telephone, video conference or other electronic means so long as (i) all members of the Board attending the meeting can communicate simultaneously with one another, including the member or members not physically present, and (ii) the arrangements for such a meeting comply with the applicable State laws concerning the conduct of electronic meetings of public bodies. Any matter of business may be considered at a special meeting of the Board, but only business connected with the emergency may be considered at an emergency meeting. [Amended March 23, 2000]

Section 2032.03 - Agenda

a. At least seven days prior to each regular meeting of the Board of Trustees, a copy of the agenda, including (insofar as is practicable) copies of all reports and other written materials to be presented to the meeting, shall be mailed-provided electronically to each member of the Board by the Secretary or Assistant Secretary. Insofar as is practicable, a copy of the agenda of each special meeting of the Board shall be mailed-provided electronically to each member of the Board at least four days in advance of the special meeting; however, if such advance mailingdistribution is not practicable, the agenda for a special meeting may be presented to the members of the Board as the first order of business at the meeting.

b. The agenda for every meeting of the Board shall be prepared by the Chancellor or his staffthe Chancellor's staff in consultation with the Chair of the Board of Trustees and with Committee Chairs as appropriate. Every request for inclusion of an item on the agenda of a meeting shall be put in writing and filed, together with any supporting documents, with the Chancellor sufficiently far in advance of the meeting to permit a determination to be made by himthe Chancellor with respect to the propriety and practicability of including that item on the agenda for the meeting.

<u>c.</u> Any member of the Board of Trustees may present to any <u>regular or special</u> meeting of the Board any item whether or not the same is on the agenda of the meeting.

Section 2042.04 - Conduct of Business

- a. A quorum of the Board of Trustees shall consist of a majority of the members trustees then in office. A quorum of any committee of the Board of Trustees shall consist of a majority of the members of the committee.
- <u>b.</u> The <u>ChairmanChair</u> shall preside over all <u>regular and special</u> meetings of the Board of Trustees. In the absence of the <u>ChairmanChair</u>, the <u>Vice-ChairmanVice-Chair</u> shall preside. In the absence of both the <u>ChairmanChair</u> and the <u>Vice-ChairmanVice-Chair</u>, a presiding officer shall be elected by and from the membership of the Board of Trustees.
- <u>c.</u> All members of the Board of Trustees may vote on all matters coming before the Board for consideration. Any voting member who attends by telephone, video conference, or other electronic means that allows for two-way voice interaction may cast his/her vote by that electronic means. No member may vote by proxy.
- <u>d.</u> Except as modified by specific rules and regulations enacted by the Board of Trustees, Robert's Rules of Order Newly Revised (latest edition) shall constitute the rules of the parliamentary procedure applicable to all meetings of the Board of Trustees and its several committees.
- e. Between regular meetings of the Board of Trustees, routine matters of business within the authority of the Board may be dealt with by written ballot and without a meeting if such is deemed appropriate by the Chair. Any action taken by this method must be ratified by the Board at its next regular meeting and recorded in the minutes of such regular Board meeting.

Section 2052.05 - Minutes

Within twenty days after each meeting of the Board of Trustees, the b. The Secretary or Assistant Secretary shall transcribe the minutes of the meeting and mail a copy provide them electronically to each member of the Board prior to the next regular meeting of the Board.

Section 2062.06 - Executive Session

By vote of a majority of the members present at any meeting of the Board of Trustees or at any meeting of a committee of the Board of Trustees, as applicable, the meeting may be closed to the public, subject to the requirements of State law concerning access to such meetings.

Section 2072.07 - Keeping Board of Governors Informed

The Secretary of the Board of Trustees, or the Assistant Secretary of the Board of Trustees on the Secretary's behalf, shall keep the Board of Governors, through the Secretary of the The University of North Carolina, fully and promptly informed concerning activities of the Board of Trustees, including notice of any changes in the membership of the Board or in its committee structure or bylaws, and notices of meetings and a copy of the minutes of all meetings.

ARTICLE III - POWERS AND DUTIES

Section 3013.01 - General Powers and Duties

The Board of Trustees shall promote the sound development of the The University of North Carolina at Chapel Hill within the functions prescribed for it, helping it to serve the people of the State in a way that will complement the activities of the other institutions and aiding it to perform at a high level of excellence in every area of endeavor. The Board of Trustees shall serve as advisor to the Board of Governors on matters pertaining to The University of North Carolina at Chapel Hill and shall also serve as advisor to the Chancellor concerning the management and development of the institution.

Section 3023.02 - Other Powers and Duties

The Board of Trustees shall have such other powers and duties, not inconsistent with provisions of *The Code of the The University of North Carolina* or with applicable provisions of State law, as are specified in said *Code* or as shall be defined and delegated by the Board of Governors.

The Board of Governors' <u>Delegations of Duty and Authority to Boards of Trustees, as amended,</u> are attached hereto as Appendix 1 and are hereby incorporated by reference. [Amended November 21, 1997 – Amended July 1, 2003]

<u>ARTICLE IV – UNIVERSITY OFFICERS</u>

Section 4.01 - Designation of University Officers

The officers of The University of North Carolina at Chapel Hill shall be the Chancellor and each Vice Chancellor. The University of North Carolina at Chapel Hill may also have such other officers as may be appointed by the Chancellor or the Vice Chancellor for Finance and Operations pursuant to Section 4.02 of this Article.

Section 4.02 – Appointment of Additional Officers

The Chancellor and the Vice Chancellor for Finance and Operations is each authorized to appoint additional officers of The University of North Carolina at Chapel Hill for the purpose of executing documents that require the signature of an officer of the University. Such appointments may be made only of University employees holding the title of Associate Vice Chancellor or Assistant Vice Chancellor, and shall terminate upon the individual's resignation or removal from such position. The Vice Chancellor for Finance and Operations may appoint officers only from among the members of his or her staff. The Chancellor or the Vice Chancellor for Finance and Operations shall promptly inform the Board of Trustees of any appointment made pursuant to this Section.

ARTICLE **₩V** – AMENDMENT OF BYLAWS

Section 4015.01 - Amendment of Bylaws

These bylaws may be amended at any regular or special meeting of the Board of Trustees by an affirmative vote of a majority of the members of the Board trustees then in office if the substance of the amendment has been filed in writing with the Secretary or the Assistant Secretary and a copy has been mailed provided electronically to each member of the Board at least seven days prior to the meeting at which the amendment is to be voted upon.

ARTICLE **VI** – SUBORDINATION TO UNIVERSITY *CODE*

Section 5016.01 - Subordination to University *Code*

To the extent that any of these bylaws may be consistent inconsistent with *The Code of* the *The University of North Carolina*, as the same may be amended from time to time, said *Code* shall control.
