RESOLUTION OF THE BOARD OF TRUSTEES OF THE UNIVERSITY OF NORTH CAROLINA AT CHAPEL HILL

Preamble

WHEREAS, a healthy democracy not only tolerates dissent, but welcomes it to help test ideas and to promote policies benefiting the public good. Vigorous debate and frank disagreement should proliferate in an open, democratic society – especially at its universities – while personal attacks and abuse undermine progress toward individual dignity, mutual understanding, and community welfare.

WHEREAS, one prominent University graduate observed recently: Threats, bullying, and intimidation have no place in our educational system. Being civil and respectful of one another is more important now than ever before.

NOW THEREFORE, to promote a positive, collegial atmosphere among students, faculty, and staff, The University of North Carolina at Chapel Hill Board of Trustees hereby invite all Tar Heels to join us in adopting this civility pledge:

"To help foster the free exchange of ideas necessary to the search for truth, I pledge to treat all students, faculty, and staff with respect, dignity, courtesy, and generosity of spirit. I acknowledge the value of varying backgrounds, experiences, perspectives, and opinions among the members of our diverse University community. We are all fallible – and each of us is equally worthy. I commit humbly to the unending pursuit of knowledge, understanding, wisdom, acceptance, and mutual support as fellow Tar Heels first and last."
